

Checklist for China Visit Visa



Dear Applicant,

Thanks for choosing MATCHLESS TOURS & TRAVELS (Pvt) Ltd as your preferred choice for travel and visa consultancy. Kindly provide the following mandatory documents to proceed your desired visa application.

- Signed Visa Application Form
- Passport (Original and copy of bio pages) with at least 6 months validity
- Previous Chinese visa (if any)
- Two photographs 33x48mm with light background one affixed to the form
- Police character/clearance certificate(attested by Ministry of Foreign Affairs of Pakistan)
- Polio Vaccination Certificate
- Visa Request Letter on Company's Letter Head

If you are visiting under the **Visitor stream(F Visa)**:

- Invitation Letter of Duly Authorized Entity or Confirmation Letter of Invitation issued by relevant Chinese entities(original)
- An invitation letter issued by a relevant entity or individual in China. The invitation should contain:
 - Information on the applicant (full name, gender, date of birth, etc.)
 - Information on the planned visit (purpose of visit, arrival and departure dates, place(s) to be visited, relations between the applicant and the inviting entity or individual, financial source for expenditures)
 - Information on the inviting entity or individual (name, contact telephone number, address, official stamp, signature of the legal representative or the inviting individual)
 - A supporting letter from the organization which the applicant serves in
 - Bank statement (personal or company, for the last six months)
 - round-trip air tickets and hotel booking (first time visit to China).

If you are visiting under the **Business Stream (M Visa)**:

- Invitation Letter of Duly Authorized Entity or Confirmation Letter of Invitation issued by relevant Chinese entities(original)

- Documents on the commercial activity issued by a trade partner in China, or trade fair invitation relevant entity or individual. The invitation letter should contain:
 - Information on the applicant (full name, gender, date of birth, etc.)
 - Information on the planned visit (purpose of visit, arrival and departure dates, place(s) to be visited, relations between the applicant and the inviting entity or individual, financial source for expenditures)
 - Information on the inviting entity or individual (name, contact telephone number, address, official stamp, signature of the legal representative or the inviting individual)
 - A supporting letter from the organization which the applicant serves in
 - The applicant's taxpayer registration certificate (NTN photocopy) and registration of the organization which the applicant serves in(NTN photocopy) and tax returns for the last 2 years
 - Bank statement (personal or company ,for the last 6 months) & Reference letter
 - Round-trip air tickets and Hotel booking (for the first time visit to China)
 - Membership certificate & recommendation letter from the chamber of commerce



Note: 1- For the first visit, the applicant should appear in person at Chinese Embassy.
2- Invitation Letter must be required for Chinese visit visa.

Chinese High Commission Islamabad reserves the right to ask for additional documents. Failure to submit all required documentation may result in the refusal of application or processing delays. Submission of Fake/Fraudulent documents is an offense. The Mission may refer such cases to relevant law enforcement authorities.
