


Checklist for New Zealand Visit Visa



Dear Applicant,

Thanks for choosing MATCHLESS TOURS & TRAVELS (Pvt) Ltd as your preferred choice for travel and visa consultancy. Kindly provide the following mandatory documents to proceed your desired visa application.

- Completed, signed application form
- Appropriate fee and immigration levy
- Two passport-sized color photographs
- 2 Clear Certified Copies of current passport
- Certified Copies of previous passport's bio pages and used pages
- Medical or chest X-ray certificates if required by Section E: Health in Application Form
- Evidence of financial support consisting of:
 - a completed Sponsorship Form For Temporary Entry (INZ 1025), or
 - Personal bank statements for the Past 6 months and Bank Reference Letter
- Evidence that you have the means to leave New Zealand consisting of:
 - a completed Sponsorship Form For Temporary Entry (INZ 1025), or
 - pre-purchased travel out of New Zealand, or
 - evidence showing you have sufficient funds in your name to purchase travel out of New Zealand.
- If your partner and/or dependent children are included in this application:
 - evidence of your relationship with your partner and/or
 - evidence that you are the parent or legal guardian of the children included in this application
- Evidence of Source of income such as.
 - Employment Letter stating your period of job, designation and current salary
 - If you are self employed then Business bank statements for the Past 6, Business Letter head paper, Visiting Card, Business Registration Certificate
 - Business NTN Certificate and Tax Returns
 - Chamber of commerce certificate and Chamber of commerce reference letter
- If you are visiting under the **Tourist stream**: Your itinerary for your stay in New Zealand.
- Evidence that you are a bona fide visitor, for example:
 - evidence that you intend to return to your home country at the end of your stay
 - evidence that you are genuinely visiting for the purpose of holidaying, sightseeing or visiting family or friends
 - Evidence of onward travel arrangements out of New Zealand.
 - Hotel Reservation
 - Air Ticket Reservation

- If you are visiting for **Business**: Evidence of proposed activities in New Zealand.
 - Evidence of the business you will undertake in New Zealand
 - Evidence of your employment or running Business in your Country or residence
 - Letter of invitation from the business in New Zealand stating the period and purpose of your visit
 - Letter from the business you are representing providing details of your visit, your length of stay, and how your visit will benefit the business; and Details and supporting financial information of how your visit will be funded. For example Bank statements from the business covering a period of three months
 - Certified copy of your National Tax Number (NTN) Registration Certificate issued by the Federal Board of Revenue for the business you are representing
 - If you are visiting under the **Family Visitor stream**: then
 - If you are visiting relatives or friends, a letter of invitation from your relative or friend in New Zealand. If your relative or friend is paying for your visit, evidence that they have the necessary funds.
 - a completed Sponsorship Form For Temporary Entry (INZ 1025)
 - Evidence of your relationship with your sponsor in New Zealand if you are parent, grandparent, sibling or other relative of New Zealand's citizen or permanent resident.
 - Other information to show that you have an incentive and authority to return to your home country, such as:
 - A letter from your employer stating your intention to return to your job
 - evidence of enrolment at a school, college or university in your home country
 - Evidence of immediate family members in your home country
 - Evidence of your visa or travelling history of other countries
 - Evidence of property or other significant assets owned in your home country.

Note: Immigration New Zealand reserves the right to ask for additional documents. Failure to submit all required documentation may result in the refusal of application or processing delays.
